2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.

A complete set of Bidding Documents may be purchased from the office: **Internal Management Section of Commission for the Investigation of Abuse of Authority (CIAA), Tangal, KTM** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs **3,000.00** (Three Thousand) **till 2079/08/27 (13<sup>th</sup> December 2022)** during office hours.
5. Sealed bids must be submitted to the office: **Internal Management Section of Commission for the Investigation of Abuse of Authority (CIAA), Tangal, KTM** by hand/courier on or before **12:00 Noon on 2079/08/28 (14<sup>th</sup> December 2022)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2079/08/28 (14<sup>th</sup> December 2022) at 2:00 PM at Commission for the Investigation of Abuse of Authority (CIAA), Tangal, Kathmandu**. Bids must be valid for a period of 90 Days from the date of bid opening and must be accompanied by a bid security shall be valid minimum 30 days beyond the bid validity period.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
