5. Bidder must be submitted their bid electronically through PPMO website www.bolpatra.gov.np/egp on or before 2079/10/06 (20th January, 2023) at 12:00 hrs. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2079/10/06 (20th January, 2023) at 13:00 hrs at CIAA, Tangal, Kathmandu. Bids must be valid for a period of 90 Days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to **NRs.2,00,000.00 (Two Lakh Rupees Only)** which shall be valid minimum 30 days beyond the bid validity period.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
