The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 09Th Jestha 2078 (23rd May 2021) at the office of Internal Management Section, Commission for the Investigation of Abuse of Authority (CIAA), Tangal, Kathmandu.
